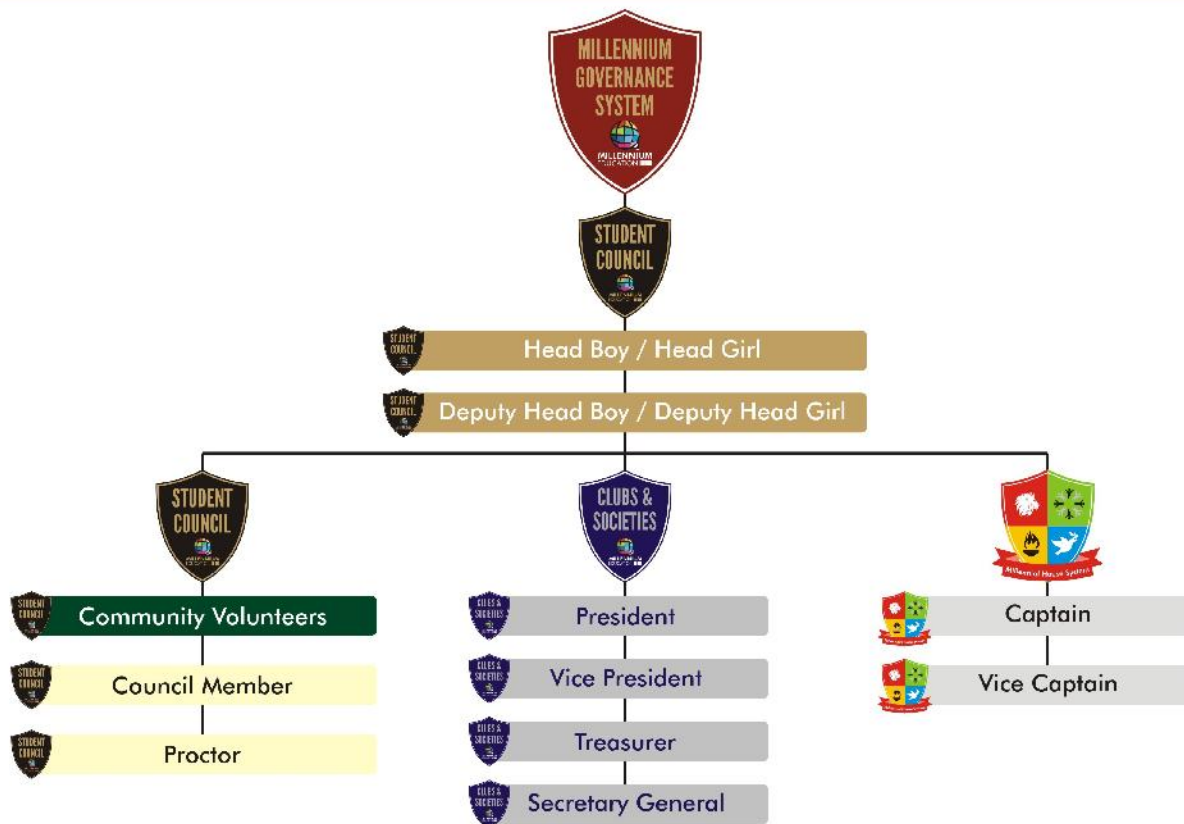

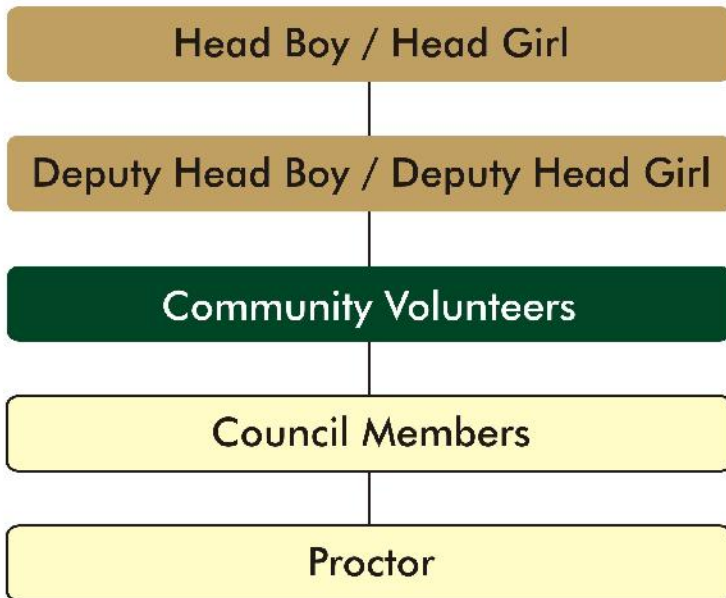

Governing Guidelines for Head Boy/Head Girl/ Deputy Head Boy/ Deputy Head Girl

ARTICLE I: MEMBERSHIP

Section A: Eligibility - Membership shall be open to all students who are keen and are interested. However, the School Principal/Headmistress along with the Academic Coordinators are to shortlist the final candidates based on the eligibility criteria given below:

ARTICLE II: OFFICERS

Section A: Officers – The officers shall be Head Boy, Head Girl, Deputy Head Boy and Deputy Head Girl.

Section B: Eligibility – Officers must be from:

- 1 Senior most class in school/college (Head Boy/Head Girl)
- 2 Second most senior class in school/college (Deputy Head Boy/Deputy Head Girl)
- 3 Exemplifies good behaviour
- 4 Maintains good attendance
- 5 Maintains a good academic record
- 6 Shows leadership qualities



Governing Guidelines for Head Boy/Head Girl/ Deputy Head Boy/ Deputy Head Girl

Section C: Selection – The officers shall be first shortlisted by a committee comprising of Principal, Academic Coordinator and teachers by first week of September. This shall be followed by School Elections where students from grade I to the senior most class shall cast their votes.

Section D: Term – The officers shall serve for one year and their term of office shall begin in September. Deputy Head Boy/Girl shall assume the office for the remainder of the term and vacancies in any other office shall be filled accordingly.

ARTICLE III: DUTIES OF OFFICERS

Section A: Head Boy/Head Girl – it shall be the duty of the Head Boy /Head Girl to:

- 1 Lead by example keeping in mind that other students will look to him/her for behaviour clues.
- 2 Vote only in case of a tie
- 3 Represent the school as they are the school's ambassadors at events both inside and outside the school.
- 4 Work with school management to provide oversight of the Governance System.
- 5 To organise and plan regular meetings with the members of the Clubs and Societies, Student Council and volunteers.
- 6 Perform such other duties that may arise from time to time.



Governing Guidelines for Head Boy/Head Girl/ Deputy Head Boy/ Deputy Head Girl

Section B: Deputy Head Boy/Deputy Head Girl – It shall be the duty of the Vice-President to:

- 1 Lead by example keeping in mind that other students will look to him/her for behaviour clues.
- 2 Work in collaboration with Head Boy/Head Girl for smooth running of the Governance System.
- 3 Represent the school with the Head Boy/Head Girl as they are the school's ambassadors at events both inside and outside the school.
- 4 To organise and plan regular meetings with the members of the Clubs & Societies, Student Council, volunteers and Class Proctors.
- 5 Perform such other duties that may arise from time to time..

ARTICLE IV: MEETINGS

Section A: Meetings – Regular meetings shall be held monthly during the regular school year.

Section B: Special Meetings – Special meetings may be called by the Head Boy/Head Girl /Deputy Head Boy/Deputy Head Girl with the approval of the School Head.



Governing Guidelines for Community Volunteers

ARTICLE I: MEMBERSHIP

Section A: Members – The officers shall be Community Volunteers

Section B: Selection - 5-6 in-school community volunteers and 5-6 out of school community volunteers to be selected by School Principal/Head/ Academic Coordinator/ Counsellor from the primary and middle year grades respectively.

Section C: Eligibility – The eligibility criteria for learners is as follows:

- School Community Volunteers shall be selected from grade VI - XI.
 - Out of School Community Volunteers shall be selected from grade XII - XIII / AS / A Level.
- 1 exemplifies good behaviour
 - 2 maintains good attendance
 - 3 maintains a good academic record
 - 4 shows leadership qualities

Section D: Term – The officers shall serve for one year and his/her term of office shall begin in August / September.



Governing Guidelines for Community Volunteers

ARTICLE II: DUTIES

Section A: Community Volunteers – it shall be the duty of the Community Volunteers to:

Out of School Community Volunteer

- 1 out of school volunteers are to complete 72 hours of community service in an academic session.
- 2 perform such other duties that may arise from time to time.
- 3 support the student council in maintaining school / college discipline during morning, recess and after school/college timings.
- 4 support the student council in maintaining discipline in out of school volunteer work.

School Community Volunteer

- 1 in school volunteers are to complete 36 hours of school community service in an academic session.
- 2 perform such other duties that may arise from time to time.
- 3 support the student council in maintaining school / college discipline during morning, recess and after school/college timings.
- 4 support the student council in maintaining discipline in out of school volunteer work.

Section B: Strength – Their shall be 10 - 12 volunteers in each campus with fair representation from each grade.



Governing Guidelines for Council Members

ARTICLE I: MEMBERSHIP

Section A: Members – The officers shall be Student Council Members

Section B: Selection - Members to be selected by School Principal/Head/ Academic Coordinator/ Counselor.

Section C: Eligibility – Officers must be from:

- 1 Second senior most class in school/college
- 2 Exemplifies good behaviour
- 3 Maintains good attendance
- 4 Maintains a good academic record
- 5 Shows leadership qualities

Section D: Term – The officers shall serve for one year and his/her term of office shall begin in August / September.



Governing Guidelines for Council Members

ARTICLE II: DUTIES

Section A: Student Council Members – it shall be the duty of the Student Council Members to :

- 1 follow the guidelines established by the school such as dress code, hours of work, adult behaviour, values and all regulations, rules, and policies stated for school employees and volunteers.
- 2 be considerate, respect competencies and work as a member of the team with the staff and students.
- 3 are expected to enrich and extend learning opportunities for students and promote excellence for the school system.
- 4 work with the Deputy Head Boy/Deputy Head Girl for smooth conduction of all activities inside and outside school/college.

Section B: Strength – 10-12 Council Members to be selected from the campus with fair representation from each grade.\



Governing Guidelines for Class Proctors

ARTICLE I: MEMBERSHIP

Section A: Members – The officer shall be Class Proctor

Section B: Selection – Officer to be selected by class teacher on a monthly basis. Each month, a new class proctor is to be selected by the Class Teacher .

Section C: Eligibility – Officer must:

- 1 Exemplifies good behaviour
- 2 Maintains good attendance
- 3 Maintains a good academic record
- 4 Show leadership qualities

Section D: Term – The officer shall serve for one month beginning from September.



Governing Guidelines for Class Proctors

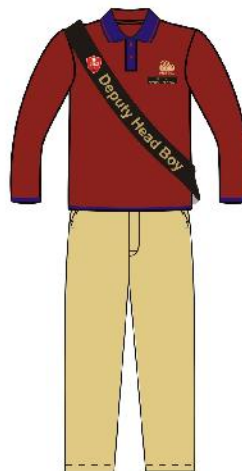
ARTICLE II: DUTIES

- 6 Assist classmates in queuing for morning assembly and after recess.

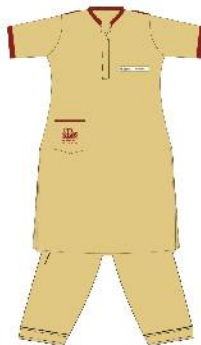
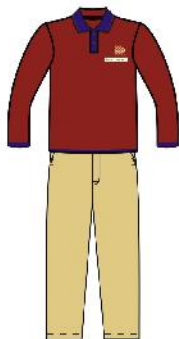

4. to draw inferences and conclusions during debates and declamations.

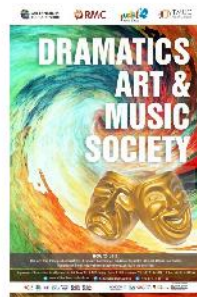

3. to foster learners' leadership skills in team effectiveness, problem solving skills and critical thinking.

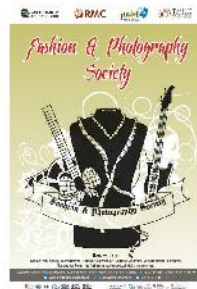

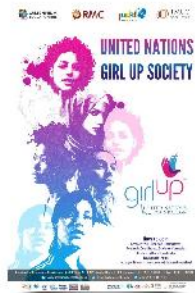

3. to develop leadership skills and make a positive difference in the lives of girls everywhere through education, fundraising, advocacy and service.

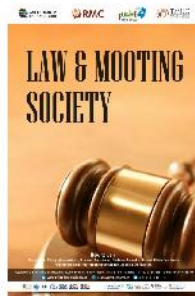

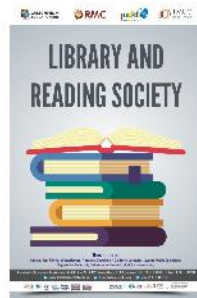

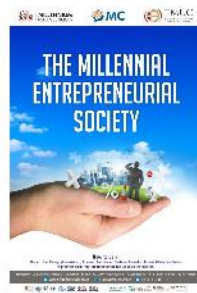

Section A: Officers – The officers shall be a President, Vice-President, Treasurer and Secretary.

Section B: Eligibility – Officers must be from:

President: Senior most class in school/college

Vice –President: 2nd senior most class

Treasurer: 3rd senior most class

Secretary: 4th senior most class

All officers must display some relevant background/experience in their chosen club/society of interest.

Section C: Selection – The officers shall be selected by a committee comprising of Principal, Academic Coordinator and teachers by first week of September.

Section D: Term – The officers shall serve for one year and their term of office shall begin in September.

Section E: Vacancy – If a vacancy occurs in the office of President, the Vice-President shall assume the office for the remainder of the term and vacancies in any other office shall be filled accordingly.

ARTICLE IV: DUTIES OF OFFICERS

Section A: President – it shall be the duty of the President to:

- 1 conduct and preside at meetings
- 2 vote in case of a tie
- 3 represent the club/ society both inside and outside the school
- 4 appoint committee chairpersons subject to the approval of the advisor assigned to the club/society and the school Head
- 5 perform such other duties that may arise from time to time.

Section B: Vice-President – It shall be the duty of the Vice-President to:

- 1 preside in the absence of the President
- 2 serve as chairperson of any committees set up by the officers of the club/ society.
- 3 record the minutes of all meetings
- 4 keep a file of the club's/society's records
- 5 maintain a current roster of membership
- 6 assist the President in all designated tasks.

Section C: Treasurer – It shall be the duty of the Treasurer to:

- 1 receive any funds and maintain accurate records of any monies being acquired/ used by the club/ society.
- 2 keep an itemised account of all receipts and expenditures and make reports, as directed, to the advisor/ school Head

Section D: Secretary – It shall be the duty of the Secretary to:

- 1 be present in all club meetings, events and activities.
- 2 issue notices of meetings and conduct the general correspondence of the club/ society.
- 3 assist senior level officer in all designated tasks.

ARTICLE V: MEETINGS

Section A: Meetings – Regular meetings shall be held monthly during the regular school year.

Section B: Special Meetings – Special meetings may be called by the President with the approval of the advisor or school Head.

Section C: Quorum – A quorum shall consist of all the position holding members of the club and/or society

ARTICLE VI: ADVISOR

Section A: Selection – There shall be a teacher working as 'advisor', who shall be selected by the school leadership each year to provide oversight to the club/ society

Section B: Duties – The responsibilities of the advisor shall be to:

- 1 maintain an awareness of the activities and programme sponsored by the student club/ society.
- 2 meet on a regular basis with the leader of the student club/ society to discuss upcoming meetings, long range plans, goals, and problems of the club/ society.
- 3 attend regular meetings, meetings with the membership of the club/ society as often his/her study schedule allows.
- 4 explain and clarify school policies and procedures that apply to the club/ society.
- 5 provide direction in the area of meeting facilitation, minutes-taking, group-building, goal-setting, and activity/ programme planning.
- 6 assist the club treasurer in monitoring expenditures, fund raising activities and other forms of sponsorship to maintain an accurate and up-to-date account ledger for the club/ society.
- 7 inform club members of those factors that constitute unacceptable behaviour on the part of the club/society members or students involved in club/ society activities, and the possible consequence of such behaviours.
- 8 submit a quarterly report on the working of the club/society.

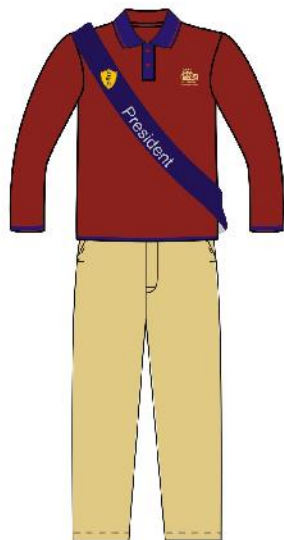

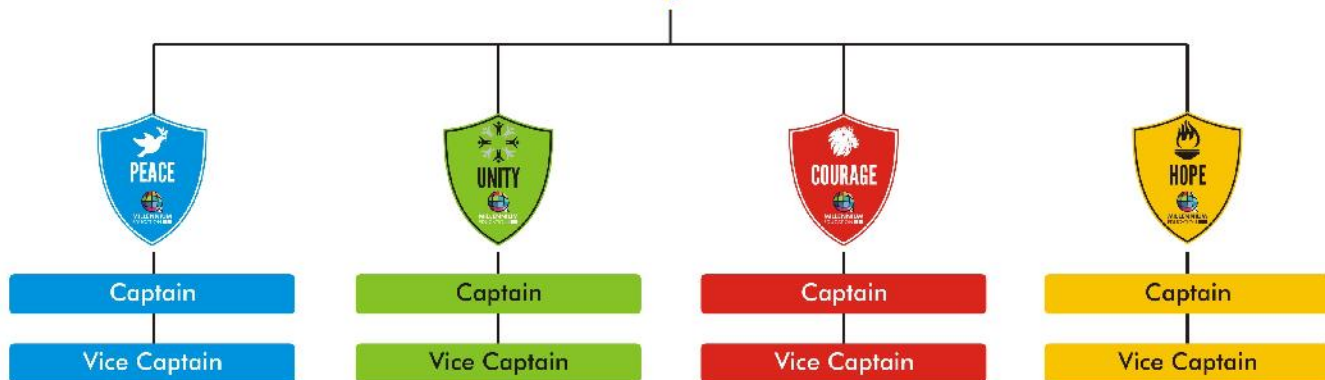

The four pillars of The Millennium House System (MHS) depict Millennium Learner Attributes that we strive to inculcate in our Millennials. The MHS supports enhancement of skills and thereby promotes Global Citizenship and Millennialism. The MHS promotes responsibility, collaboration, inclusivity, opportunity, diversity, discovery and accountability.



Peace: for a Better Tomorrow

Peace is the concept of harmony and the absence of hostility.

Millennials learn the basic principles of humanity and are to advocate for peace. They tend to be reflective and exhibit responsible global citizenship in every action and prove themselves to be tolerant and supportive.



Unity: for a Passionate Present

Unity is the state of being united or joined as a whole. Millennials learn to collaborate, work together to bring about synergy and achieve goals. They are engaged and learn to be responsible to progress as a whole. They maintain focus and adapt shared responsibility for every task.



Courage: to Never Give in

Courage is the choice and willingness to confront agony, pain, danger, uncertainty, or intimidation. Millennials learn, reflect, practice and exhibit courage with sportsmanship attributes. They tend to be reflective and confident.



Hope: for a Brighter Future

Hope is an optimistic state of mind that is based on an expectation of positive outcomes with respect to events and circumstances. Operational Guidelines

1. The Millennium House System (MHS) constitutes of 4 houses.
2. All Millennials in each section of a campus are to be divided into houses in equal number.
3. Millennials score points according to the following table:

International Achievement	35
Disciplinary Issue/Breach of Student Code of Conduct	-10

4. Educate your Campus's Teaching and Non-Teaching Staff about the operation of Houses and to report achievements and misconducts to allocate scores to respective Houses.
5. You are to dedicate a board in the campus, as a Scoreboard (Exhibit II) to update scores on ground level for maximum visibility.
6. Scoreboard can be maintained by House Leader after Principal's/Headmistress'/Academic Coordinator's consent.
7. House Leader is advised to be selected by the Principal/HM or rotation (term-wise).
8. House Captains and Vice-Captains are selected amongst learners of the 2nd highest grade of the campus.
9. There is only one pair comprising of: House Captain and Vice House Captain from each campus and for every house.



House Constitution

Article I: Name & Purpose

Section A: Name - The name of this Houses shall be: Peace, Unity, Courage and Hope.

Section B: Purpose - The purpose of the Houses shall be:

1. to develop good attitudes of sportsmanship, and ethical behaviour among students.
2. to train students for different sports, extra-curricular and co-curricular activities according to their interest and to develop the capacity to make reasoned decisions about relevant issues and to work effectively within a group toward common goals.
3. to foster the importance of team spirit, discipline and leadership qualities among the students.
4. to foster the sense of shared responsibility amongst students.

Article II: Membership

Section A: Eligibility - Membership shall be open to all students who are keen and take interest in leading Houses.

Article III: Officers

Section A: Officers - The officers shall be a Captain and a Vice-Captain for each House.

Section B: Eligibility - Officers must be from:

Captain: Senior most class in school/college

Vice - Captain: 2nd senior most class

Section C: Selection - The officers shall be selected by a committee comprising of Principal, Academic Coordinator and teachers by first week of September.

Section D: Term - The officers shall serve for one year and their term of office shall begin in September.

Section E: Vacancy - If a vacancy occurs in the office of Captain, the Vice-Captain shall assume the office for the remainder of the term and vacancies in any other office shall be filled accordingly.

Article IV: Duties of Officers

Section A: Captain - it shall be the duty of the Captain to:

- Preside at meetings
- Vote in case of a tie
- Represent the house both inside and outside the school
- Perform such other duties as they may arise from time to time.

Section B: Vice-Captain - It shall be the duty of the Vice-Captain to:

- Preside in the absence of the Captain
- Serve as chairperson of any committees set up by the officers of the House
- Record the minutes of all meetings

Article V: Meetings

Section A: Meetings - Regular meetings shall be held monthly during the regular school year.

Section B: Special Meetings - Special meetings may be called by the House Captain with the approval of the Mentor or School Head.

Article VI: Mentor

Section A: Selection - There shall be a teacher working as 'mentor', who shall be selected by the school leadership each year to provide oversight to the House.

Section B: Duties - The responsibilities of the mentor shall be to:

- meet on a regular basis with the leader of the student House to discuss upcoming meetings, long range plans, goals, and problems of the House.
- attend regular meetings, meetings with the membership of the House as often his/her study schedule allows.
- explain and clarify school policies and procedures that apply to the House.
- provide direction in the area of meeting facilitation, minutes-taking, group-building, goal-setting, and activity/ programme planning.
- inform club members of those factors that constitute unacceptable behavior on the part of the House members or students involved in House activities, and the possible consequence of such behaviors.
- submit a quarterly report on the working of the House.

Article VIII: Amendments
